KSH AWARDED JTC CONSTRUCTION CONTRACT WORTH APPROX S\$59.9 MILLION

- ***Strong order book rises to approximately S\$489.0 million***

Singapore, April 2, 2013 . KSH Holdings Limited (KSH or the Group) (KSH 控股有限公司), a well-established construction, property development and property management group, today announced that its wholly-owned subsidiary company Kim Seng Heng Engineering Construction (Pte) Ltd (KSH EC) has been awarded a construction contract worth approximately S\$59.9 million by Jurong Town Corporation (JTC), for a construction project at Ayer Rajah Avenue.

For this contract, KSH EC will erect a single storey building with a basement, landscape park, carpark, storage space and shell space for a district cooling system plant at Ayer Rajah Avenue. Construction will commence in April 2013 and is expected to be completed by January 2015. With this new project, the existing order book of the Group's construction business continues its uptrend to approximately S\$489.0 million.

Said Mr Choo Chee Onn, Executive Chairman and Managing Director of KSH, "We are pleased to be awarded this project by Jurong Town Corporation, a strong endorsement of the public sector's recognition of KSH's expertise in building high quality projects. For more than 34 years, KSH has built a wealth of experience in constructing public and private sector projects. Going forward, we will pay greater emphasis to public sector construction activities, and look for suitable opportunities in this sector."

In the public sector, recently completed projects by KSH include the construction of primary schools at Punggol Site 18 at Punggol Place and Sengkang Site 12A at Anchorvale Link, for the Ministry of Education. Also, for the National University of Singapore, KSH built two blocks of 21-storey Residential Colleges with a two-storey Podium, five blocks of two-storey Common Facility Buildings for NUS University Town and a four-storey Education Resource Centre with Lecture Theatre for NUS University Town.

Listed on the Main Board of SGX-ST on February 8, 2007, KSH is a well-established Construction, Property Development and Property Management group. Incorporated in 1979, the Group has over 34 years of experience in the Singapore construction industry and is backed by an impressive track record, both in Public and Private Sector construction projects. The Group is registered with the Building and Construction Authority (BCA) with an A1 grading under the category CW01 for general building, which is currently the highest grade for contractors registration in this category, and allows the Group to tender for Public Sector construction projects of unlimited value. The Group is also registered with an A2 grading under BCA's CW02 category for civil engineering, which allows it to tender for Public Sector projects for values of up to S\$85.0 million.

Besides acting as a main contractor for both the Public and Private Construction sectors in Singapore, and for the Private sector in Malaysia, KSH is also involved in Property Development and Property Management in Singapore as well as the People's Republic of China (PRC).
