

## ACQUISITION OF NEW COMPANIES IN THE BRITISH VIRGIN ISLANDS

The above investment in Horizon Glory and Joy Light were funded through internal resources and are not expected to have any material impact on the net tangible assets and earnings per share of the Company and the Group for the current financial year ending 31 March 2016.
